Item No. 3: Any other matter with the permission of the chair.

i) To consider letter dated 14/1/2019 received from Prin. K.P. Mangalvedhekar Institute of Management Career Development and Research, Solapur regarding finalization of fees for MBA course for A.Y. 2018-19.

Read communication dated 14/01/2019 received from Prin. K.P. Mangalvedhekar Institute of Management Career Development and Research, Solapur. It appears that the college failed to submit fee proposals from the A.Y. 2013-14 to 2019-20. Issue Show Cause Notice.

The fees for A.Y. 2013-14 to 2019-20 can only be decided after going through statement of accounts and other relevant documents. These documents have not been submitted by the college.

ii) To consider the letter dated 28/1/2019 received from (i) Suraj Institute of Management, Beed, (ii) Mitthulalji Sarda MBA College, Beed (iii) Kishori College of MBA, Beed regarding finalization of fees for A.Y. 2018-19.

Read communications received from (i) Suraj Institute of Management, Beed, (ii) Mitthulalji Sarda MBA College, Beed, (iii) Kishori College of MBA, Beed. These Institutes did not submit fee proposals for A.Y. 2018-19. Hence issue usual Show Cause Notice. The fees for A.Y. 2017-18, 2018-19 will be decided while considering fee proposals for A.Y. 2019-20, submitted by the respective institutes.

iii) To consider the letter dated 17/1/2019 received from Nanded Physiotherapy College & Research Centre, Nanded regarding approval of Ad-hoc fees for A.Y. 2015-16.

Read communications received from Nanded Physiotherapy College & Research Centre, Nanded. The college started conducting Physiotherapy course in A.Y. 2015-16. Fee proposal for A.Y. 2019-20 has been submitted. Grievance of the institute is that the Adhoc fees Rs. 54,620/- for A.Y. 2015-16 is yet to be confirmed.

While dealing with fee proposal for A.Y. 2016-17 decision regarding fee proposal for A.Y. 2015-16 was expected. Inadvertently this was left out. Therefore, the Adhoc fee of Rs. 54,620/- for Physiotherapy course for the batch in A.Y. 2015-16 is confirmed.



iv) To consider the letter dated 9/1/2019 received from Universal College of Engineering, Palghar regarding non-submission of fee proposal for upward revision of fees for A.Y. 2019-20.

This relates to the fees for the academic year 2018-19 relating to BE course run by the institute.

The matter is subjudice in the nature of WP No. 1506 of 2017. The institute has been allowed to collect fees of Rs. 1,17,000/- by the Hon'ble High Court in the said matter for the previous academic years.

In view of the above and subject to the decision of the Hon'ble High Court, same fee structure shall apply for the academic year 2018-19.

The college be informed accordingly.
